The Affirm team has been providing financial software solutions for over 10 years and our systems manage over 200,000 documents and contracts.

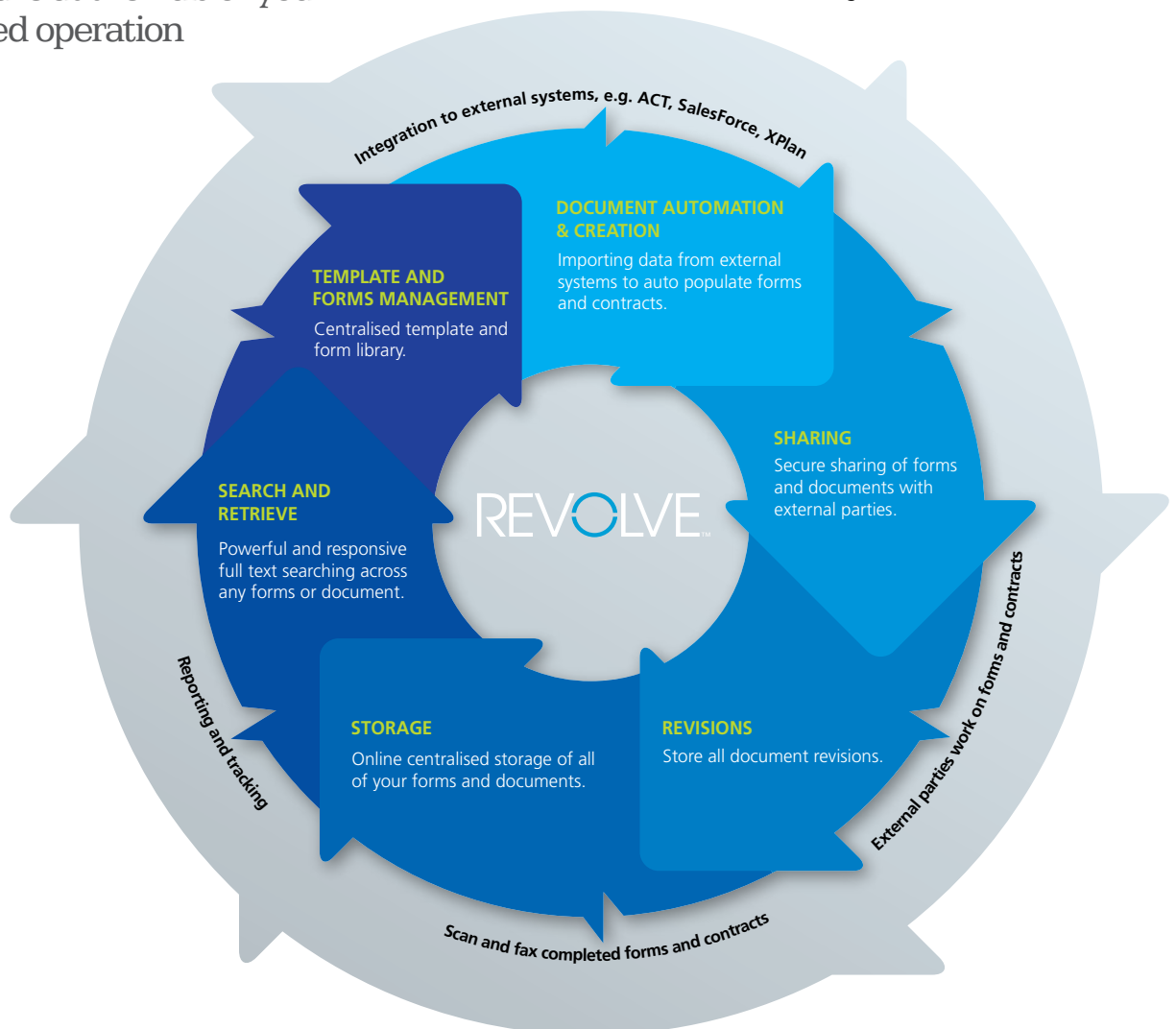
